in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said *A. L. Vaughn*, all of my one half (1/2) undivided interest of, you and to
all that piece or lot of land in *Greenville*, Township, Greenville County, State of South Carolina,
and being the following metes and bounds, to-wit:
beginning at a point on *McGee Street*
on the north side of a ten foot alley, said
point being 16.5 feet from the northwest intersection
of *East Avenue* and *McGee Street*, and
running thence with *McGee Street* N. 31° 45' E.
51 feet to corner lot no 5-3, thence S. 80° 34' along
line of lots nos 5-2 and 5-3, 15.5 feet to an
iron pipe on a ten foot alley, thence along *East*
leading on from *McGee Street*, thence along
north side of second mentioned alley N. 80° 34'
15.5 feet to beginning being lot no 6-2 as

balance due thereon being about \$700.00
2. Note and mortgage given by *J. O. Jones* and
A. L. Vaughn to American Building and Loan
Assn. in the sum of \$600.00 dated February 27,
1920, and recorded in Mortgage Book 21, page
207, R. M. C. Office for Greenville County, the balance
due thereon being approximately \$2300.00
3. The grantee herein assumes the balance due
on account of curb and gutter assessments
due to the City of Greenville, also the 1929
State and County taxes.
