all that piece parcel or lot of land in Quaten Township, Greenville County, State of South Carolina

near the Lawrence Road, 1/2 mile north of Simpsonville having the following metes and bounds: Beginning at a stake in road leading from Bethel Road to Simpsonville to S. Stone corner and running thence N. 26.20 E. 5.31 to stone thence S. 61.45 E. 9.24 to stone thence N. 25.30 E. 6.20 to iron pin in road, thence along center of road N. 65.20 E. 21.65 to road in road, thence N. 75.24 E. 17.17 to beginning containing 14.66 acres, according to survey of W. J. Riddle, June 1924.
