C. office in Plat book 7, page 44, having the following courses and distances: Beginning at a stake on Jamison Street, 400 feet east of the intersection of Valley and Jamison Streets and running thence along Jamison Street S. 53° 40' 58" feet to iron pin. Corner of lot 48; thence along line of lot 48, S. 42° 43' W. 155.7 feet to iron pin. Corner of B. F. Martin's property; thence along line of Martin property N. 46° 32' 4.997 feet to iron pin, corner of lot 46; thence along line of lot no. 46, N. 42° 43' E. 149.5 feet to the beginning corner.
