KNOW ALL MEN BY THESE PRESENTS, That:

a corporation chartered under the laws of the State of South Carolina, in the State of South Carolina, for and in consideration of the sum of One Thousand Forty-four & 95/100 (\$1,044.95) DOLLARS, in cash and assumption of Two Thousand Ten (\$2,010.00) Dollar Mortgage.

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee, hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto *Carl E. Higgin*

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the Northern side of Randall Street, in the City of Greenville, and being known and designated as a portion of lot No. 23, Section A of the property of Stone Lamb Company and having to a part of the property of Stone Lamb Company, being according to a plat of the property of Ruth E. Walker, and prepared by Dalton & Nease, Engineers, January 1931, the following metes and bounds, courses and distances, to wit: Beginning at an iron pin on the North side of Randall Street, which pin is 233 feet from the Northeastern intersection of Hiller and Randall Streets, thence N. 64° 48' 113.8 feet more or less to an iron pin; thence S. 74° 30' E. 53.25 feet to an iron pin; thence S. 64° 47' W. 110.6 feet more or less to an iron pin on the North side of Randall Street; thence with said street N. 83° 13' N. 53 feet to the point of beginning. This deed is made subject to a Three Thousand (\$3,000.00) Dollars mortgage executed by Ruth E. Walker to the South Carolina Security Company and assigned to the Metropolitan Life Insurance Company. This mortgage has been paid in full by South Carolina Security Company, there being a balance due of Two Thousand Ten (\$2,010.00) Dollars.

It is understood and agreed that the grantee, Carl E. Higgin, by accepting this deed, agrees to pay off the balance of this mortgage with interest at the rate of six (6%) per cent per annum, from date.

The above described lot of land is the same conveyed to the South Carolina Security on the 29th day of August, 1932, and recorded in the R.M.C. office for Greenville County in Deeds 144, page 168.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee, hereinabove named, and *her* heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee, hereinabove named, and *her* heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
