All that certain piece, parcel or lot of land situate, lying  
and being in the State and County aforesaid, near the corporate  
limits of the city of Greenville, on the North side of Paris Mt. Ave.  
and being known and designated as the Western one half of lot #13 of the  
property of D. C. Bear, as shown on a revised plat made February 9, 1922,  
by W. M. Rich Long, and recorded in the office of R. M. C. for Greenville  
County in Plat Book "N" page 142, and having according to said plat  
the following metes and bounds To Wit:Beginning at an iron pin at the intersection of Paris mt. Ave  
and Alley and running thence with Paris mt. Ave. N. 84-02 E. 50  
feet to a stake; thence S. 6-00 W. 175-4 feet to a stake; thence S. 84-02  
W. 50 feet to iron pin on Alley; thence with said alley S. 6-00  
E. 175-4 feet to the beginning corner.As a part of the consideration of the purchase price hereof  
the grantee herein agrees to be governed by the following building  
restrictions:

- (1) No houses to be built on said lot costing less than \$ 5000.00.
- (2) Property to be used for white residence purposes only. Not to be  
applied to servants houses.
- (3) All lots to remain to be governed by sanitary rules and regulations  
governed by a majority of property owners in this subdivision.
- (4) To bear his proportion of expense toward the upkeep of the sewer
