All that certain piece, parcel and tract of land situate, lying and being in Greenville Township, County and State aforesaid, adjoining lands of J. L. Garrett, M. G. White and others, having metes and bounds as follows: Beginning at a stone on the Standing Spring Baptist Church line and running thence S. 13° 34' E. 16.23 to stone; thence S. 51° 34' E. 10.03 to stone; thence S. 10° 34' E. 3.23 to stone; thence S. 51° 34' E. 13.63 to an iron pipe in road; thence with road N. 9° 44' E. 1.00 to bend in road; thence N. 8° 1/2 E. 4.65 to bend; thence N. 32° 1/2 E. 3.20 to a white oak on the south side of the Standing Spring Branch; thence up the mulberry sapling of said branch N. 48° 5.00 to bend; thence N. 26° 34' E. 8.80 to iron pin, at the Henderson corner (Formerly J. R.
