at and before the sealing of these presents by

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *L. F. Simpson, Jr., his heirs and assigns,* all that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and, in Greenville Townships, being known and designated as lot #63 of a subdivision known as Augusta Circle, and having according to a plat of said subdivision recorded in the R. M. C. Office for Greenville County, in plat book "F", at page 303, the following metes and bounds:

Beginning at an iron pin 50 feet from the northeast corner of Tassae Avenue and Mayah Street joint corner of lots 62 and 63, and running thence with Tassae Ave. N. 21-35 E. 50 feet to corner of lots 61 and 62; thence with joint line of said lots S. 71-35 E. 166.36 feet to an iron pin joint corner of lots 61, 62, 50 and 51; thence S. 21-35 W. 50 feet to an iron pin joint corner of lots 62 and 63, said pin being 50 feet from Mayah Street; thence along the line of lots 62 and 63 N. 71-35 W. 166.36 feet to the point of beginning. Also, all that piece, parcel or tract of land being known and designated as a part of lot #60 according to a plat of a subdivision known and designated as Augusta Circle, said plat being recorded in the R. M. C. Office for Greenville County in plat book "F", at page 205, and being definitely described as follows:

Beginning at an iron pin joint corner of lots 62 and 63, and running thence S. 21-35 W. 50 feet to an iron pin on Mayah St.; thence along Mayah St. S. 71-35 W. 50 feet to a point in line of lot 60; thence S. 71-35 E. 10 feet to the beginning corner, and being a step of 10 feet off the rear of lot #63.

It is understood, and agreed, that the grantee agrees by accepting this deed expressly to assume and promises to pay a certain mortgage executed by H. J. Martin to Washington Savings & Trust Co. in the sum of \$3,000.

The above described land is the same conveyed to me by *L. F. Simpson, Jr.* on the 10th day of June, 1930, deed recorded in office of Register of Deeds Conveyance for Greenville County, in Book *TOGETHER*, with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said *L. F. Simpson, Jr., his heirs and assigns, forever.*

AND myself, my *L. F. Simpson, Jr., his* heirs and assigns, against *my* heirs, and against every person whomsoever lawfully claiming, or to claim the same, or any part thereof.
