Mrs. Lillie A. Nash, her heirs and assigns forever.

All the following described pieces, parcels or lots of land situated, lying and being in Greenville County, State of South Carolina and having the following metes and bounds, to wit:

First: Lot No. 20 and 49 ac. Should be part of Teague's
Measly made by R. E. Dalton, Surveyor, July 1911, fronting on
Railroad and Center Streets respectively and having the following
metes and bounds, to wit:

Beginning on a stake, corner of lot No. 19 and running
thence S. 12° 56' W. 30 feet to a stake; thence N. 30° 47' W. 120.4
feet to a stake on side of Center Street; thence N. 15° E. 80
feet with said Street to a stake; thence S. 74° 30' E. 120 feet
to the beginning corner, and being the same lots conveyed
