All that lot of land situated on the north side
of East Mcbee Avenue, in the City of Greenville,
Having the following metes and bounds
to-wit:

Beginning at a point on East Mcbee Avenue
in Satterfield's line and at the corner of a
concrete wall and running thence with
Satterfield's line 56 feet, more or less, to a
point on Satterfield's line; thence in an
easterly direction with Satterfield's line, 9 feet
to a point; thence still with Satterfield's
line in a northerly direction 55 feet, more or
less, to Griffis' line; thence in an easterly
direction with Griffis' line, 16 feet to a
division fence, four six line of the beamon;
thence with line of beamon and along
said division fence 20 ft. 9 1/2 feet, more
or less, to a point on East Mcbee Avenue;
thence with East Mcbee Avenue 25 feet to the
beginning corner. This being the same lot
