All that certain piece, parcel or lot of land situated in the City of Greenville County of Greenville, State of South Carolina, on the North side of Croft Street between North Main Street extension and the extension of Townes Street, and being the eastern one-half of Lot No. 44 of Section 13 of the property of Stone Land Company, part of which is recorded in the A.M.C. Office for Greenville County, in Plat Book 4 at pages 887-845 and having, according to said plat the following metes and bounds, corners and dimensions, T.D.W.D.

Beginsing at an iron pin on the North side of Croft Street, said pin being 800 feet east of the North East corner of Townes and Croft Streets, and being also the joint corner of lots Nos. 44 and 46 of Section 13, as shown on plat above referred to, and running thence along the joint line of said lots N. 41 & 200 feet to an iron pin on the South side of an Alley, thence along the South side of said Alley, N. 80-18 W. 100 feet to an iron pin, thence through the center of lot No. 44 of Section 13, S. 1-41 W. 200 feet to an iron pin on the North side of Croft Street, thence along the North side of Croft Street, S. 1-82-18 E. 50 feet to the point of beginning.
