Beginning at a stake at the intersection of Brockman Street and National Highway and runs thence west - Brockman Street S. 12-00 W. 100 feet to a stake, thence with being Street S. 78-00 E. 810 feet to a stake, thence N. 12-15 E. 1350 feet to a stake on the National Highway, thence with said Highway N. 78-00 W. 210 feet to the J. beginning corner, and being known and designated as lots 87, 88, 89, 90, 91 and 92, on a tract of land known as the J. E. Brockman and Mrs. J. H. Lancaster property near Greenville, S.C. all of the above lots was deeded to me by Marie B.
