the Register of Deeds for Greenville County) has lot No. 1 of Block 86, front-  
ing 11.8 feet on Chicora Ave. and having a depth of  
116.5 feet along the City Street back line, to Greenville  
& Western Railroad of which, this being the same lot  
conveyed to me by H. M. Conyers & J. B. Gower by their

of Deeds for Greenville County Vol. 63 page 256.

further known as Riverside, and described (on the plat referred  
to above as Lot # 2 of Block 86) having a frontage on  
Chicora Ave. of 50 feet and running back to a depth  
of 120.5 feet on its Northern side and 121.8 feet on its  
Southern side. This being one of the lots conveyed to  
me by Riverside Land Co. by its deed dated Jan 11th  
1921 recorded in Office of the Register of Deeds for Greenville County Vol. 111 page 397.
