Utilities Company, a corporation, its successors and assigns the right, privilege and  
easement to go in and upon that tract of land in the state and county aforesaid, lying  
along a road known as Bradley Street on the eastern side, 189 feet frontage between Mr.  
Couch and Mr. Clayberne.

and to construct and maintain in, upon, and through said premises, in a proper manner, with poles, wires and other necessary apparatus and appliances, a line for
