valuable considerations to it paid by the Southern Public Utilities Company, a corporation  
in the state aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained,  
sold and released unto the said Southern Public Utilities Company, a corporation, its suc-  
cessors and assigns the right, privilege and easement to go in and upon that tract of land  
in the state and county aforesaid, lying along a road running from Greenville to Andersen  
known as State Highway No. 8.

and to construct and maintain in, upon, and through said premises, in a proper manner, with poles, wires and other necessary apparatus and appliances, a line for  
the purpose of transmitting power by electricity, together with the right at all times to enter upon said premises for the purpose of inspecting said lines and  
making necessary repairs and alterations thereon; together with the right to cut away and keep clear of said lines all trees and other obstructions that may, in  
any way, endanger the proper operation of the same. Said line from said Highway to C. & G. Ry. right of way.
