(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said  
Pure Oil Company of the Carolinas Inc,

All those certain pieces parcels of lots of land situate, lying and being in the County of Greenville, State aforesaid, on the West side of Paris Mountain Road and being more particularly described as follows, as shown on plat of J. M. Perry subdivision recorded in Plat Book F, at page 127 (revised plat recorded in Plat Book H, page 184, R. M. C. Office for Greenville County.)

Beginning at a stake on Paris Mountain Road, joint corner of lots 72 and 73 and running thence S. 58-30 W. 151.5 feet to a stake; thence along line of lot No. 72 N. 31-30 W. 65 feet to a stake joint corner of lots 71 and 72; thence across Lot No. 70 S. 58-30 W. proximately 12 feet to a point in right of way of New Buncombe Highway; thence along the east side of said New Buncombe Highway right of way in a Southwesterly direction to a stake on right of way of Southern Railway Company; thence along line of lots #69, 70 and 73 N. 61-23 E. 194.76 feet, more or less, to a stake on Paris Mountain Road; thence along Paris Mountain Road, N. 1-17 W. 92.9 feet to the beginning corner, and being all of lot No. 73 as shown on said plat and all of lots Nos. 69 and 70 on the East side of New Buncombe Highway expressly excluding however a small triangular portion of lot No. 70, lying between lot No. 71 and the New Buncombe Highway.
