(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

John S. Hammett:

All our right, title and interest on the proceeds from the sale thereof in and to all that piece or parcel or lot of land in Chick Sarge Township, Greenville County, State of South Carolina, and containing 1.31 acres, more or less, and adjoining lands of B. P. Edwards, J. D. Holtzman, the said John S. Hammett, Robert Bowlin, et al, and being the tract of land of which Jerah Hammett died seized and possessed, having the following metes and boundaries: Beginning at a stake in the center of the road leading from Taylor toward Rusby Creek Church and running thence along the said road as the line

- S. 40 1/2 E. 198 feet

to a stake in the center of the road; thence S. 62 1/4 N. 172 1/4 feet to an iron pin; thence S. 10 3/4 E. 623 3/4 feet to a stone; thence S. 34 1/2 E. 693 feet to an iron pin; thence S. 76 1/4 E. 567 1/2 feet to a white Oak on the bank of Cane Creek; thence up the said Cane Creek as the line about 705 feet to an iron pin on the said Creek; thence S. 53 1/2 N. 151 feet to an iron pin; thence S. 75 3/4 N. 749 feet to an iron pin; thence S. 54 1/2 N. 257 feet to an iron pin; thence S. 73 1/4 N. 89 feet to a maple; thence N. 61 1/4 N. 50 feet to an iron pin; thence N. 63 1/4 N. 165 feet to an iron pin; thence S. 22 1/4 44 feet to a Hickory; thence N. 61 N. 1071 1/2 feet to a stone in an old road; thence N. 23 1/4 E. 223 1/4 feet to a white Oak on a branch; thence N. 5 1/2 E. 254 1/2 feet to a stone near the residence of B. V. Hudson; thence N. 27 1/2 E. 240 1/2 feet to a stone; thence S. 85 E. 410 1/2 feet to the beginning corner.

Also all our right, title and interest in and to any personal property or the proceeds from the sale thereof which is owned by the estate of the said Jerah Hammett.
