KNOW ALL MEN BY THESE PRESENTS, That I, A. G. New
of Greenville County,

in the State aforesaid,
in consideration of the sum of
Ten DOLLARS,
and assumption of mortgage stated below
to me in hand paid at and before the sealing of these presents by
Mrs. Maude Ellen (Horley) New

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Mrs. Maude Ellen (Horley) New:

All that certain lot of land in the County and
State aforesaid in the City of Greenville, beginning at an
iron pin on the north side of East Park Avenue 51 ft 4 in
from N. 34 corner of the intersection of Park Avenue and
Vannoy Street and running thereof N. 20-45 E. 172 ft to
an iron pin, thence N. 77-11-50 ft to an iron pin, thence
S. 20-45 E. 172 ft to an iron pin on Park Ave, thence
with Park Avenue S. 77 E. 56 ft to beginning corner.

Also all that other piece, parcel or lot of land sit-
uate, lying and being in Ward 2 of the City of Greenville
County and State aforesaid, also having the following
metes and bounds to wit: Beginning at an iron pin
on the north side of East Park Avenue 51 ft. 4 inches from
the northwest corner of the intersection of Park Avenue
and Vannoy Street, corner of lot conveyed to Josie L.
Floyd by L. D. Yarborough on March 24, 1917, and running
thence with line of said lot N. 20-45 E. 132 ft to an iron pin
on line of lot conveyed to Josie L. Floyd by L. D. Yarborough
on July 8, 1918, and running with line of said lot in a line
parallel with Park Avenue S. 11 E. feet.

with interest on both notes.
