All that piece, parcel or lot of land in Paris Mt. Township, County and State aforesaid, North of the City of Greenville, and being known and designated as lots Nos. 51, 52, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 64, 65, 66 and a portion of No. 67 on plat of property of J. P. Rosamond made from a revised plat of property of Sals Souci Development Company made by Dalton & Neves, Engineers, and recorded in A. M. C. office for Greenville County in Plat Book H, at pages 185-186 and having according to said plat the following metes and bounds, to wit:
