of the Lessee, bankrupt or otherwise, provided, however, that any subsequent assignee, tenant or lessee, shall take and hold subject only to the provisions and conditions hereinabove prescribed; and if the proceeds of this additional lien on stocks, etc., should be insufficient to pay the whole of said rent, then the landlord shall have the right to apply the same on the rental for the term as far as it will go and to terminate the lease thereafter, any subsequent tenant, assignee or lessee for any portion of the term to take under the same conditions and provisions as prescribed in this paragraph, term to take under the same conditions and provisions the entire remaining portion of the term hereunder.
