Whereas, *Neilie E. Watson, et al.*

our Lord nineteen hundred and thirty six exhibited plaintain complaint in the  
Court of Common Pleas, for the County aforesaid, against Malvern Watson.

demanding relief as to the real estate described in the complaint, and the cause being at issue, came on to be heard on the 4th  
day of September, 1936, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was  
adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. J. Dunnass.  
Master in and for the County aforesaid, to J. E. Beamaney,  
for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. E. 6002.)

NOW, Therefore, Know all Men by these Presents, that I, E. J. Dunnass,  
Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$360.48  
HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said J. E. Beamaney, his  
heirs and assigns:

All that certain piece parcel or tract of land situate,  
lying and being in the State and County aforesaid, near  
Cross Roads Church, and having the following metes  
and bounds, to-wit:

Beginning at an iron pin in the center of road to  
Anderson's Bridge, corner of tract No. 1 and running thence  
with the old road bed ad the line S. 51 E. 100 feet to a pin;  
thence S. 39-54 E. 200 feet to a pin; thence S. 55-05 E. 183 feet  
to a pin; thence S. 141-39 E. 228 feet to a large stone; thence  
S. 86-19 E. 615-7 feet to a flint rock; thence S. 58-40 E. 100 feet  
to a double stone; thence N. 45-40 W. 2264.5 feet to a stone;  
thence S. 36-18 W. 611 feet to Center of road 'K' Greenville (iron  
pin, 17 feet from center of road); thence S. 55-15 E. 300 feet  
to iron pin in center of intersection of Greenville Road  
and road to Bennett's Bridge; thence S. 34-45 W. 70 feet  
to an iron pin in center of road to Simpsonville;  
thence S. 48-27 E. 727.5 feet to iron pin, the beginning  
corner, containing twenty-six and eight-tenths acres  
(26.8A), more or less, and being known as tract No. 2  
of the sub-division of H. A. Snell land as per survey  
made by H. B. Brookman, Surveyor, October 3, 1927.

As a part of the consideration for this conveyance  
the grantee assumes and agrees to pay a note in  
the principal sum of Seven Hundred (\$700.00) Dollars  
given by Mrs. L. R. Watson to Land Bank Commissioner  
which is secured by a mortgage of record in the  
R. M. C. Office for Greenville County in Mortgage Book  
247, Page 111, on which there is interest of \$29.64 due  
as of this date, and. Also, the grantee assumes the  
payment of the State and County Taxes for 1936, on  
the basis of \$9.88, making a total of \$739.52, which the  
grantee assumes and agrees to pay.
