HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

P. S. Jarrard and W. H. Jarrard
All the right, title and interest of the minor
Defendant, Wm. Henry Cleveland, in and to the
following described real estate:

All that certain piece, parcel or tract of land
situate, lying and being in the State of South
Carolina, County of Greenville, near the town of
Marietta on the East side of Cleveland, are leading
from Marietta to Brevard, N. C. and having according
to a recent survey made by W. M. Past Engineer, the
following metes and bounds, to-wit:

Beginning at an iron pin on the east side of
Cleveland Ave, at the corner of Townsends land,
and running thence along the east side of said
Ave S. 0-45 E. 737 feet to an iron pin corner of
Girard land, thence along Girard line, N. 68 E. 670 feet
to an iron pin (joint corner of Girard Tract); thence
still with Girard line, S. 9-04 E. 420 feet to an iron
pin (joint corner of Girard Tract, and Slater tract);
thence with Slater line, N. 68 E. 687 feet to an iron pin,
thence N. 11 24. 633.5 feet to an iron pin, corner or, in
line of Townsends property, thence N. 85-15 24. 1,000 feet
to the beginning corner, on the east side of said
street. Said Tract contains 30 acres, more or less.

Also all that certain piece, parcel or tract

Township on the East side of Bell Highway at a
