and being a part of the tract of land conveyed to the said E. M. Holliday by C. H. and C. G. Acker in 1904. Said tract of land hereby conveyed being more particularly described as follows:

Lying on both sides of a public road leading from the Princeton Road to the Woolly Bridge Road through the Holliday and Acker places and being bounded on the North by lands of C. H. Acker estate, and on the South by lands of Ruth Holliday, on the West by lands of H. S. Bothran, on the East by lands of the C. H.
