assigns forever, in that piece parcel or tract of land situate, lying
and being in the State and County aforesaid on the head waters of
South Tiger River and in Saluda Township and mostly on the north
side of the Ridge Road, near Cross Plains Church, being the remainder
of the land belonging to the W. S. Pitman, deceased, Estate, and having,
