Wood Brown, running to edge of Bluff, on the Northwest by lands of Jesse Milford, and more fully shown by plat of same made by Thos. C. 39. That tract of land on Reedy River, above Tumbling Shoals, containing 37.60

Acres, more or less, bounded on the West by Reedy River and on all other sides by the land now or formerly of Perry Sullivan, as shown by plat made by McCready Bros. & Chevis, Inc., January 14, 1914, being the land conveyed to the Sullivan Power Company by Perry Sullivan by deed dated July 24, 1915, recorded in Book 39, page 149, and by the Sullivan Power Company conveyed to the National Utilities Company of South Carolina by deed dated February 15, 1928, recorded in Book 57, page 27; including herein all those rights, privileges, and easements granted to the Sullivan Power Company by Perry Sullivan by deed dated November 13, 1913, recorded in Book 27, page 152.

The party of the first part hereby excepts from this conveyance that certain lot or parcel of land containing 2.08 Acres, more or less; bounded on the North, East and West by lands formerly of the Sullivan Power Company, and on the South by lands of the New Prospect Baptist Chruch, Colored, described as follows:

All and singular the buildings, structures, plants, engines; boilers, pipes, machinery, dynamos, generators, conduits, poles, wires, mains, lamps, transformers, insulators, meters, meter supports, power houses, distributing stations, sub-stations, transformer stations, lighting and rest houses, tanks, wells, pumps, shops, and all equipment, apparatus, tools, and appliances owned, used, and/or held for use in connection with the maintenance and operation of any and /or all of the generating, transmitting, and distributing systems of the party of the first part and/or used in connection with its business of the generation, transmission, distribution and sale of electricity in and about Laurens County and Greenville County, S. C.

Also all rights of way, rights, privileges, easements and contracts under and by virtue of which the National Utilities Company of South Carolina has acquired any rights of occupancy or rights of way or other rights in, upon or over any lands or other property; including in said property, but not limiting the generality of the foregoing description, those rights of way and other rights hereinafter set out, to wit:
