

"All that certain lot of land, with improvements thereon, situate
in the City of Greenville, County of Greenville, State of South
Carolina, on the Eastern side of South Laurens Street, in the Block
between W. M^e Bee Ave. and West Washington Streets, and having,
according to a plat thereof prepared by C. M. Furman, Esq., Engineer,
October 23, 1909, the following course and distance, to wit:

Begging at a point on the Eastern side of South Laurens Street
142 feet, 4 $\frac{1}{2}$ inches North of the Northeastern intersection of West M^e Bee
Avenue and South Laurens Street, which intersection is in the center
of a brick wall, and running thence along the Eastern side of
South Laurens Street N. 18° 15' E. 1 foot 3 inches to an iron pin in
the center of a brick wall; thence following the center of said brick wall
S. 71° 00' E. 10 $\frac{1}{2}$ feet, 9 $\frac{1}{4}$ inches to an iron pin; thence S. 18° 15' W. 3 feet,
1 inch to an iron pin; thence S. 71° 00' E. 12 feet, 1 inch to an iron
pin; thence S. 18° 15' W. 2 $\frac{1}{2}$ feet, 5 inches to an iron pin; thence S.
71° 00' W. 11 $\frac{1}{4}$ feet, 11 $\frac{1}{4}$ inches (said line passing through the center of
the brick wall first above mentioned) to the point of beginning."


