Township, Greenville County, State of South Carolina.

All that certain lot, piece, or parcel of land, with the buildings and improvements thereon situate, lying and being near the City of Greenville County of Greenville State of South Carolina, within the corporate limits of the City of Greenville known and designated on the Plan known as the Subdivision of lot 61 recorded in the R. M. C. Office for Greenville County in Plat Book F at page 223, and having according to survey made by Dalton & Newell November 18, 1925, the following meter and bounds to wit:

Beginning at a point on the East side of M.G. Aloe Avenue, which point is 170.1 feet from the Laurens Road, and running thence S. 74° 12' E. 150 feet along the side lines of Lots #55, 59 and 60 to a point, thence S. 15° 48' 24" 50 feet to a point, joint corner of Lots #61 and 62, thence N. 74° 12' 24" 150 feet to a portion M.G. Aloe Avenue, thence along M.G. Aloe Avenue N. 15° 48' 24" 50 feet to the point of beginning.

This deed is an absolute conveyance of title in effect as well as in form and is not intended as a mortgage, trust conveyance, or security of any kind. The consideration therefor is full release of all debts, obligations, costs and charges heretofore subsisting on account of and by the terms of that certain mortgage herein existing on the property hereinconveyed (which mortgage is executed by *J. H. Christopher* to *Wm. H. Hunt Company of Maryland* and *Edgar J. Hecht* as Trustee, and recorded in the R. M. C. Office for Greenville County for Mortgages Platine 183 at page 245) and note secured thereby, this conveyance completely satisfying said obligation and terminating said mortgage and note and has effect thereof in all respects, as recorded in office of Register of Deeds in Greenville County, South Carolina.

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said *Lewis Barber*, his heirs and assigns forever

AND I do hereby bind myself, and my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said *Lewis Barber*, his heirs and assigns, against me and my heirs, and every other person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
