in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mollie C. Freeman, her heirs and assigns, all our right title and interest, in and to, the same being an undivided two-thirds interest in and to, Precinctville, Township, Greenville County, State of South Carolina,

near the City of Greenville, known as lot no. 51 on the plat of Highlands, property of J. H. Harris, recorded in the Office of Register of Mesne Conveyance for said County in Plat Book 6, page 146, said lot having a frontage of 80 feet on the west side of Virginia Avenue, and running back in parallel lines to the right of way of the P. & M. Railroad, bounded on the north by lot no. 52 and on the south by lot no. 50, as shown on said plat.

This is the same lot which was conveyed to J. H. Freeman by Sallie H. Harris by deed dated September 24, 1919, and recorded in Deed Book 53, page 180, R. M.
