

TITLE TO REAL ESTATE

STATE OF SOUTH CAROLINA.

KNOW ALL MEN BY THESE PRESENTS, THAT I, E. P. Hartsell, of Greenville,

In the State aforesaid.

In consideration of the sum of Nine Hundred (\$900.00)

Dollars,

to me paid by P. A. Rogers.

In the State aforesaid, the persons whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said P. A. Rogers, his heirs and assigns;

all that piece, parcel or lot of land in Greenville

Township, Greenville County, State of South Carolina,

in the City of Greenville, on the south side of Jenkins Street;

Beginning on the south side of Jenkins Street at the southwest corner of said street and a 20-foot alley, at a fence post; thence with Jenkins Street, S. 67-50 E. 63 feet to a fence post on the LaFayette Cannon corner; thence with the line of LaFayette Cannon property S. 32-50 W. 61 feet to the corner of Hattie Wofford lot; thence with the Hattie Wofford line, N. 69 W. about 50 feet to the said 20-foot alley; thence along the line of said alley, N. 13-20 W. 82 feet to the beginning corner, being the same lot which was conveyed to me by Ben Jenkins, deed dated February 14, 1939, recorded in Deed Book 148, at Page 220, R. M. C. office for said Greenville County, except that the corners of Jenkins Street have been set back about 5 feet, to widen Jenkins Street. Said corners are now established where the fence posts are now set.

Included in the consideration above stated of \$900 is the agreement by the grantee that he is to assume the payment of the balance owing to The Carolina Loan and Trust Company on note and mortgage executed by the grantor to said Company, which amount is \$300.

The above described land is the same conveyed to me by Ben Jenkins, on the 14th day of February 1929, deed recorded in office of Register of Mesne Conveyance for Greenville County, in Book 148, Page 220.

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said P. A. Rogers, his

heirs and assigns forever.

AND I do hereby bind myself and my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said P. A. Rogers, his heirs, and every other person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
