KNOW ALL MEN BY THESE PRESENTS, That I, John Hunt, of Greenville, S. C.

in the State aforesaid.

In consideration of the sum of Ten (\$10.00) and love and affection,

to me paid by Minnie Pearl Bryant,

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Minnie Pearl Bryant, her heirs and assigns,

all that place, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina,

on Hampton Avenue Extension, being lot No. 9 of T. Q. Donaldson lands, represented by a

plat recorded in Plat Book A, page 217, in R. M. C. office for said Greenville County,

Said lot has the following mowers and bounds:

Beginning at corner of lot No. 8 on Hampton Avenue; thence running northerly with joint line of lots Nos. 8 and 9, 150 feet to a ten foot alley; thence with said alley easterly fifty (50) feet to corner of lot No. 10; thence with joint line of lots Nos. 9 and 10 southerly 150 feet to Hampton Avenue (Extension); thence with said Hampton Avenue, westerly fifty (50) feet to the beginning corner. This is the same lot which was conveyed to me, the said John Hunt by T. Q. Donaldson, et al. by deed dated May 27, 1925, recorded in Deed Book 117, page 31, in the R. M. C. office for said Greenville County.

It is distinctly understood that this deed conveys all of the lot known as lot No. 9, except four feet and eleven inches adjoining lot No. 8, which is reserved by the grantor, and the intention of this deed is to convey fifty (50) feet frontage on Hampton Avenue Extension, with a depth of 150 feet.

The above described land in the same conveyed to me by T. Q. Donaldson, et al., on the 27th day of May 1925, deed recorded in office of Register of Deeds Conveyance for Greenville County, in Book 117, Page 31.

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said Minnie Pearl Bryant, her heirs and assigns forever.

AND I do hereby bind myself and my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said Minnie Pearl Bryant, her heirs and assigns, against all and every other person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
