all that piece, parcel or lot of land in Saxit Township, Greenville County, State of South Carolina,

near Conster Hill containing one fourth of an acre, more or less adjoining lands of E. J. Hampton, Aaron Walker, & St. Shavers, and abtained on the Standing Spring Road and having the following meter and corner: Beginning at an iron pin on said Standing Spring Road and running thence S 88° E 247 chains to an iron pin; thence N 20° E 93 links to an iron pin; thence N 70° E 3.16 chains to an iron pin on said road, thence along said road 1.61 chains to the beginning corner and being the same lot conveyed to H. M. Vaughan by E. J. Lumbkin, Master, by deed dated Dec 3rd, 1915, and recorded in the R. M. L. Office for Greenville County in vol. 52 page 287.
