being lot No. 12 of New Hope, a subdivision of land represented by plat recorded in Plat Book A, page 307, R. M. C. office for Greenville County. Said lot lies on the north side of Cobb Street, and has a frontage on said street of sixty feet and a depth of one hundred fifty feet.

This is the same lot conveyed to said Mattie Odom and Martha E. Odom by John J. Odom, Augt 17, 1914, recorded in Deed Book 31, page 573, said R. M. C. office; in this deed a life estate is reserved for said Martha E. Odom, and the said Mattie Odom is granted the land with the exception of the life estate for Martha Odom, her mother, but the grantors unite in this deed and convey to The Carolina Loan and Trust Company a fee simple title, absolute in intent as well as form.
