An undivided one-half interest in and to the following, all that certain piece or lot of land containing *47 1/2* acres, more or less, and being the tract conveyed to me by Parker Land Co. in deed dated July 27, 1920, recorded in Vol. 53 at page 420, recorded in the R.M.C. Office for Greenville County, State of South Carolina, less eight (8) acres conveyed by me to Messrs. Hughes, the original tract having contained *55 1/2* acres, more or less.
