all other prices, parcels or lot of land.

All that piece parcel or lot of land situate, lying and being in Greenville Township and on West St., and being Lot #37 and 38 of the West Land, and having the following lines and boundaries, to wit:

Beginning at an iron pin on said West Street, at corner of Lot #37 and running thence N. 13-21 E. 120 feet along West St. to an iron pin corner of Lot #36, thence with line of Lot #36 N 85.9° to an iron pin, thence S. 14-25 E. 113.2 feet to an iron pin corner of Lot #39, thence along line of Lot #39, 143.3' to the beginning corner as before, by point of R. L. West Land recorded in R. M. C. Office for Greenville County in Plat Book C page 190 and being the same lot of land conveyed to me by J. P. Palmer by deed bearing date 22nd day of January 1932, and recorded in R. M. C. Office for Greenville County in Book 161 at page 117.
