## TITLE TO REAL ESTATE

KNOW ALL MEN BY THESE PRESENTS, THAT I, James Goodlett

in the State aforesaid, the aforesaid wherof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Cora A. Cox

all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, about one and one-half miles North of the County courthouse and having the following

metes, bounds, courses and distances, to-wit:

Beginning at a point on the western side of the Old Paris Mountain Road, 58.75 feet in a southerly direction from the joint corner of James Goodlett and Richardson property, which point is in the center of the James Goodlett lot, the entire frontage of the Goodlett lot being 117.5 feet; thence S. 42-37 W. 132 feet to the rear of said lot, being the center of said James Goodlett lot and 58.75 feet in a southerly direction from the intersection of the Goodlett and Richardson lots running thence S. 19 E. 58.75 feet to an iron pin; thence N. 42-37 E. 132 feet to an iron pin in the line of the Old Paris Mountain Road; thence along the western side of the said Old Paris Mountain Road N. 19 W. 58.75 feet to the point of beginning. Being the southern one-half of the two lots conveyed to the party of the first part by Hudson B. Jackson and recorded in the R. M. C.
