All that certain piece, parcel and lot of land in Greenville Township, Greenville County, State aforesaid, and being a portion of Lots Nos. 20 and 22 of Block "C" on plat of Property of Julie D. Charles, recorded in Plat Book "E", Page 209, and having the following lines and bounds, to-wit:

Beginning at a stake on Gordon St., which stake is 250 feet East of intersection of Gordon St. and Texas Ave., and running thence with Gordon Street N. 71 E. 50 feet to stake at corner of Lot No. 22; thence in a southerly direction with line of said lot 160 feet to a stake; thence S. 71 W. 45/33 feet to stake, corner of lot heretofore conveyed to Jeff R.
