All our right, title and interest, the same being an undivided one-sixth interest each, totaling two-thirds interest, in and to the following described tract of land, containing 8 acres, more or less;

All that certain piece, parcel or lot of land situate, lying and being on the South side of the White Horse Road and head-waters of Golden Grove Creek, and having the following metes and bounds, said tract lying near lands of lot No. 7 of the subdivision of Rosemond land and adjoining Sam Rosemond, Bud Ware, et. al., and being the second described tract in the deed of Fannie C.
