## TITLE TO REAL ESTATE

Township, Greenville County, State of South Carolina,

in the City of Greenville, in Ward Five, being on an alley eighteen feet wide, running in a southerly direction from Gower Street, now known as Gower Alley, described as follows: Beginning at a stake in alley, Fannie Kelly's corner, thence with her line 96 feet to stake on Dean's line; thence with Dean's line 60 feet to stake, Wm. Mathew corner; thence with his line 98 feet to alley; thence with said alley to the beginning corner.
