Farr, their heirs and assigns, all that place, parcel or lot of land in Greenville, Township, Greenville County, State of South Carolina, about four (4) miles Northwest from Greenville County Court House, and being Tract No. 13 of sub-division of lands of the Estate of Mary C. Cunningham and property of Frank Cunningham, et al. and having the following notes and bounds, as shown by plat of said property made by R. H. Dalton, Engineer, and recorded in Plat Book G, pages 54 and 55, R. M. C. Office for Greenville County, and containing eleven and 67/100 (11.67) acres, more or less.

Beginning at an iron pipe in the Cedar Lane Road, corner of said Tract No. 13, and Land of Hedges, and running thence with said Road N. 7-10 W. 717 feet to an iron pipe in said Road, corner of Tract No. 12; thence with line of Tract No. 12, S. 68-0 W. 877.5 feet to an iron pipe in line of Tract No. 4, said point being the joint corner of Tracts Nos. 10, 12, and 13; thence with line of Tract No. 4, S. 35-10 E. 311.3 feet to an iron pipe joint corner of Tracts Nos. 3 and 4; thence with line of Tract No. 3, S. 35-10 E. 480.7 feet to iron pin on Hedges line; thence with said Hedges line N. 60-0 E. 523 feet to the beginning corner.
