all that piece of ground situate, lying and being in Grove Township, Greenville County, S. C., on the

West side of the Moenville public road about 12 miles from Greenville on the waters of Grove Creek bounded on the North by lands this day conveyed by me to Mrs. Ollie May Randall on the East by the Moenville public road; on the south by lands of Effie C. Basy and on the West by Mitchell property and having the following lines and bounds, to-wit:

Beginning at an iron post on the Moenville public road at the southeast corner of the tract conveyed this day by me to Mrs. Ollie May Randall and running thence with said Moenville Post S. 40 $\frac{1}{2}$ E. 1.91 chs. to the corner of Effie C. Basy property; thence with her Line S. 34 $\frac{1}{2}$ W. 23.36 chs. to stiles in line of Mitchell property; thence N. 40 $\frac{1}{2}$ W. .67 chs. to stiles; thence N. 32 $\frac{1}{2}$ E. 23.36 chs. to the beginning corner, containing 2.97 acres, being a portion of the same tract of land conveyed to the grantor herein by H. C. Turner.

It is understood that there is a mortgage covering the above described tract and other property, in the sum of Eleven Thousand Dollars heretofore executed by me to the Federal Land Bank Commissioner, the payment of which mortgage has been assumed by Mrs. Ollie May Randall, and it is understood that this conveyance is made subject to said mortgage.

The above described land is the same conveyed to me by Ruth Cooper, Esq., on the 10th day of January, 1934, deed recorded in office of Register of Deeds Conway, in Greenville County, in Book Page.

wife and forever defend all and singular the said premises unto the said Effie C. Basy, her heirs, executors and administrators to heirs and assigns, against all and singular persons, and every other person whomsoever lawfully claiming, or to claim, the same, in any part thereof.
