DEED TO REAL ESTATE

KNOW ALL MEN BY THESE PRESENTS, That Bradford D. Cochran,

In the State aforesaid.

In consideration of the sum of Four Hundred (\$400.00) Dollars,
and the assumption of the mortgage hereinbelow set forth
to me paid by Mrs. Ollie May Randall.

In the State aforesaid the rights whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the sum Mrs. Ollie May Randall.

all that piece, parcel or tract of land --

All that tract or parcel of land containing 31 acres, more or less, in Grove Township, Greenville County, State of South Carolina, known as the Carlie Mitchell place, located on the Moonville public road, 12 miles from Greenville on the waters of Grove Creek, bounded on the North by lands of Jimmie Ginn and Moonville Road; on the East by lands of Effie C. Baty; and on the west by lands of Jimmie Ginn, and having the following courses and distances according to survey made by Frank Atkins, Surveyor, January 1934.

Beginning at an stone pile and stake corner of Jimmie Ginn land, running thence with Ginn line N. 49-30 E. 1473 feet to iron pin on Moonville Road; thence road the line S. 47-45 E. 232 feet to angle in road; thence road still the line S. 41 E. 442 feet to an iron pin on Moonville public road northeast corner of a 2.97 acre tract conveyed this day of Bradford D. Cochran to Effie C. Baty; thence with line of said 2.97 acre tract S. 39 $\frac{1}{2}$ W. 23.86 chains to stone; thence N. 40 W. 1121 feet to the beginning corner.
