in Ward Five (5) of the City of Greenville, having the following rates and bounds:

Beginning at a point on the line of Memminger St., 133 feet from the northeast corner of Arlington Ave. and Memminger St., thence S. $73\frac{1}{2}$ E. 60 feet to a stake; thence N. $16\frac{1}{2}$ E. 60 feet to a stake on the south side of a private alley; thence along said alley N. $73\frac{1}{2}$ W. 60 feet to an iron pin on Memminger St.; thence with Memminger St. S. $16\frac{1}{2}$ W. 60 feet to the beginning corner.
