having the following mates and bounds:

Begining at the northwest corner of Nichols Street and Green Avenue, and running thence along Green Avenue northeasterly about 52 feet to Frank White lot; thence with Frank White line westerly 94 feet to a pin; thence Southwesterly 56 feet to a point on Nichols Street 46 feet from the corner of Green Avenue; thence with Green Avenue easterly 86 feet to the beginning corner.
