

TITLE TO REAL ESTATE

I, we, and by, Emily Arnold,in the State aforesaid, the said land wherein in hereby acknowledged, have granted, bargained, sold and released, and by those presents do grant, bargain, sell and release unto the said Emily Arnold, her heirs and assigns,at that place, person or lot of land in Greenville Township, Greenville County, State of South Carolina.

In the City of Greenville, being known and designated as lot No. 11, according to a survey of J. M. Dixon, and a part of lot No. 4 of the lands surveyed by J. N. Southern, having the following mates and bounds, to-wit:

Beginning at the corner of lot No. 4 according to the J. N. Southern survey at the intersection of Leach Street and Arlington Avenue, (formerly Garlington Street); thence along Arlington Avenue 50 feet; thence parallel with Leach Street 100 feet; thence running 50 feet to Leach Street; thence along Leach Street 100 feet to the beginning corner. Said land being more fully described in the deed from Stanwix May filed to said Emma C. Franklin, dated July 30, 1889, and recorded in the R. M. G. office for said Greenville County in Deed Book VV, page 186.
