Woodside all that piece, parcel or lot of land in One within Township, Greenville County, State of South Carolina,

in the City of Greenville, said lot being in the rear of that lot of land on South Main Street known as the Mason property, and was the following conveyed and distance: Beginning at a point on the line between the property of granite, aka that of Howard, which point is subject to the the east side of which street and curbing, thence in a southerly direction 20 feet to a point, thence westerly 20 feet to a point, thence southerly 2 feet to the north side of a lot, thence along the north side of said alley, approximately 10 feet to the rear corner of lot recorded in mortgage to Matting First Mortgage Corporation recorded in book 14 page 273; thence along the rear corner of said lot in a westerly direction 4 feet 6 inches to corner of property; thence along the lot property in a westerly direction approximately 10 feet 6 inches to the beginning corner. It is expressly understood that the grantee herein does not assume the payment of any lien or indebtedness against the property herein conveyed, but merely takes the title thereto subject to such lien.

Woodside, her heirs and assigns, against all and singular the claims, demands, suits, actions, damages, costs, charges, expenses, and every other person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
