

TITLE TO REAL ESTATE

Woodside all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina,

and the City of Greenville, said lot being in the rear of that lot of land on South Main Street known as the Hanson & Hardee property, and has the following course and distances: Beginning at a point on the line between the property of granite and that of Cleveland, which point is 150 feet from the East side of Graham Street and extending thence in a southerly direction 20 feet to a point; thence westerly 50 feet to a point; thence southerly 2 feet to the north side of a ten foot alley, thence along the north side of said alley, approximately 105 feet to the rear line of lot described in mortgage to National First Mortgage Corporation recorded in Book 104 page 273; thence along the rear line of said lot in a northerly direction 42 feet 6 inches to corner of one property; thence along the one property in a westerly direction approximately 90 feet 5 3/4 inches to the beginning to wit.
