All that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid in Ward (2) of the City of Greenville, on the East side of Vanney Street known and designated as a portion of lot #35 Section "H" according to a plat of the Stone Land Company, which plat is of record in the R. M. C. Office for Greenville County in Plat Book "A", at page 337. Said lot having a frontage on the east side of Vanney St. of 50 feet and running back in parallel lines a depth of 217 feet.
