On the State aforesaid, the copy whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Eleanor H. Sanders, her heirs and assigns forever:

All that piece, parcel and lot of land, lying and being on the southeast side of Butler Avenue in Ward One of the City of Greenville in the said state, and being the same lot of land conveyed to L. J. Herrick by McIntosh by deed recorded in book TT at page 191, and by the said M. J. Herrick devised to the said Elizabeth Axon;

Beginning at a stake 150 feet from corner of Hampton Ave. and Butler Ave., and running thence with the said Butler Ave. S. 18° W. 50 feet to a stake; the corner of what was formerly C. A. Herricks line; thence S. 64 $\frac{1}{2}$ E. 156 feet to F. A. Walter's corner; thence with the said F. A. Walter's line N. 18° E. 50 feet to Richardson's line; thence N. 64 $\frac{1}{2}$ W. 156 feet to the beginning corner, containing 7,800 square feet, more or less, and being the same lot of land conveyed to me by Athena P.
