all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina,

in Ward One of the City of Greenville, known and designated as Lot "D" of Map 6 of lands formerly belonging to Mountain City Land & Improvement Company, according to a survey thereof made by J. W. Southern, recorded in Deed Book WW, page 605, and having the following metes and bounds as per plat, to-wit: beginning at a stake on the north side of Marie Street on corner of Lot "N" and running thence along said Marie Street S. 84 1/2 W. 50 feet to corner of lands formerly owned by Stone Land Company; thence along line of said land N. 5 1/2 E. 200 feet to a stake; thence N. 84 1/2 W. 50 feet to a stake; on corner of lot "N"; thence along line of lot "N", S. 5 1/2 W. 200 feet to the beginning, being the same lot of land conveyed to me by H. P. McGee by deed dated Dec. 31, 1931, recorded in R. M. C. O. for said County in Deed Book 163 page 154.
