all that piece, parcel or lot of land in Township, Greenville County, State of South Carolina,

in the City of Greenville, on the South side of Washington Street, and having the

following notes and bounds to-wit:

Beginning at an iron pin on south side of Washington St., also Mrs. Hannah Cox's line, and running thence with said Cox's line S. 23 $\frac{1}{2}$  W. 21 $\frac{1}{2}$  feet to an iron pin; thence N. 66 $\frac{1}{2}$  W. 66 $\frac{1}{2}$  feet to an iron pin; thence N. 23 $\frac{1}{2}$  E. 21 $\frac{1}{2}$  feet to an iron pin on Washington St.; thence with Washington St. S. 66 $\frac{1}{2}$  E. 66 $\frac{1}{2}$  feet to the beginning corner, being the same lot of land conveyed to C.
