near Mayaguez Mill, and being a part of the lands of Riverside, said lots being known  
 and designated as Lots No. 7, 8, 9, 10, and 11 in Block F, on the plan of Riverside,  
 which is recorded in the R. & C. Office for said County and State in Plan Book A, at  
 page 323. Said lots having a frontage of fifty (50) feet each on Highlawn Avenue, and  
 a depth of 125 feet to an alley, and adjoining each other, and being the same lots of
